"We have been working hard on plans for the building, the menu, and the service we intend to provide our guests. 1917 will offer a dining choice for every palate and price point", said Darrin Senn, Owner/Partner 1917. "We are really looking forward to showcasing our menu which is being created by a number of individuals with extensive culinary backgrounds".

Kim Senn added "The team has been working hard to complete as many projects as we can prior to May 1st. We are committed to providing a fun and relaxed experience for our guests through unique food and drink choices and intentional excellent service from our staff".
